

**1. Registration Fee**

A payment of **\$100.00 per family** must accompany the application form(s). This is **non-refundable**.

**2. Course Fees**

**Grades 8 and 9**

For students from HCOS or another school, \$460 for the first course and \$205 per subsequent course is charged. FOR HCOS STUDENTS: HCOS will cover this cost and will charge the student’s curriculum account \$150 per course, if applicable. Costs for extracurricular activities are not included in the cost of the course. Extra charges will be billed for field trips, retreats, travel & lodging for any school event that the student participates in.

**Grades 10 through 12**

The family is charged \$460 for first course and \$205 per subsequent course up to a maximum of 3 courses in total. FOR HCOS STUDENTS: If applicable, HCOS may cover \$150 per course out of the student’s curriculum account. Costs for extracurricular activities are not included in the cost of the course. Extra charges will be billed for field trips, retreats, travel & lodging for any school event that the student participates in.

**3. Tuition**

Tuition is received to supplement the cost of education for your students. We are a Group 1 Independent School, so we receive 50% of the per-student-funding given to School District #23. If you choose to withdraw your students early from HCS, 10% of the remaining tuition for the year will be held to cover administration costs.

**4. Secondary Tuition Supplement**

This added tuition helps supplement our middle and secondary school programs. It can be paid in full or built into the monthly tuition payments. **This is non refundable.**

**5. Round Up**

This fee is optional. It will be used to help families that would not normally be able to attend our school or families that run into short term financial problems.

***Tax Information***

Parents will receive income tax deductible receipts each February for the following amount:  
Tuition - 60%; Secondary Tuition Supplement - 60%.

*KCC/HCS Donation Policy: Spending of funds is confined to HCS projects and programs approved by HCS, and each designated donation will be used as directed. In the event that the funding for a particular project or program is met, or it cannot be completed for any reason determined by HCS, the remaining designated donations will be used where needed most.*
