

## 1. Tuition

Tuition is received to supplement the cost of education for your students. We are a Group 1 Independent School, so we receive 50% of the per-student-funding given to School District #23. If you choose to withdraw your students early from HCS, 10% of the **remaining tuition** for the year will be held to cover administration costs.

## 2. Tax Information

The payee(s) will be issued a charitable tax receipt every February for the portion of tuition paid that pertains to religious instruction.

The amount of this receipt varies from year to year and is calculated in accordance with the Canada Revenue Agency requirements.

In recent years, on average, Heritage Christian School families have benefited by receiving a charitable tax receipt equivalent to approximately 60% of total tuition. This benefit may be used to reduce the amount of personal income tax paid and, consequently, reduce the total cost of tuition.

### For Example:

A family with two children would pay \$5,750 in annual tuition, or \$575 per month, and receive a charitable tax receipt of approximately \$3,450.

Based on 2016 tax rates, the charitable receipt would generate non-refundable federal & provincial tax credits of approximately \$1,460.37. Therefore, the annual net-after-tax cost of tuition would be only \$4,289.63 or \$428.96 per month, \$146.04 less than the posted monthly tuition rate.

## 4. Secondary Tuition Supplement

This added tuition of **\$100 per grade 8 to 12 student** helps supplement our middle and secondary school programs. It can be paid in full or built into the monthly tuition payments. **This is non refundable.**

## 5. Tuition Assistance

An Assistance application is available to be filled out online. Regular tuition will be charged until the application is submitted and approved. Assistance is based solely on your family's income. Funds allocated are limited so families applying early have a better chance of qualifying for some assistance. ## 6. Parent Participation

To further our community spirit every family will complete 20 hours volunteer in areas of the school where they feel gifted. The \$200.00 is debited from your bank account on June 1st if you have not completed the hours. It is our desire to see that each family participate in their child's education so that it is not necessary to deposit the preauthorized payments.

## Tuition Payment Calculation Form 2017/2018

### Registration Fee & Re-enrolment Deposit/Fee

A payment of \$100.00 *per family* must accompany the application form(s). This is **non-refundable**. The \$100 Re-enrolment deposit will be applied to the family account at the beginning of the school year., but is non-refundable in the case of a withdrawal before Sept 30, 2017. A \$100 registration fee will be collected for all new families and for families that missed the re-enrolment deadline. The registration fee and the re-enrolment fee are not applied to the family account.
